**SUMMARY & BACKGROUND**

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

- ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.
- ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. The Superintendent of Schools collaborated with stakeholders to gain input on the use of these funds in the following ways:

- Design and distribute a open survey that described the purpose of these funds and sought out input.
- Communicated the survey through the weekly newsletter for employees and families; placed the request on the District's webpage; used social media to promote; discussed the use of the funds prior to Board of Education meetings in public space; discuss the intent with the Board of Education; and discussed the funding source with high school students during class meetings.

The Hannibal Central School District has collaborated with the district's architect to identify areas within each school building to improve conditions that ultimately support conditionings.

The following items are included to support the district while using the CDC; BOCES Safety and Risk; NYS and local Health Department recommendations for opening and operating safe conditions for our educational environment:

- The school district has evaluated the specific needs of students using a pupil study model. We have discovered that there are needs in the following areas that should be addressed in the following ways: Class size reduction in the fifth grade. Not only will this allow for students to be distanced from one another per CDC guidance, we have identified this grade level has having proportionately higher needs of supports required to recover requisite knowledge for the grade level. Additional Academic Interventions Services and Rtl supports are being increased to meet the specific needs of our students. Further, we have increased staffing to build professional and healthy relationships with students to increase student's confidence and understanding of the transition to becoming more independent in their decision making regarding topics such as hygiene. We have used District and federal funds to further evaluate conditions of all buildings. We have discovered that we should immediately address external doors to assist in improving air quality and making our school water tight. Further, we acknowledge the need to renovate our toilet rooms to allow staff to better clean and maintain them. (i.e. Scrubbable surfaces, improved areas of privacy, etc.) Increase outdoor instructional space for physical education by creating and building an exercise area.

The goal is to use all CDC, NYSDOH, and recommendations given to us by our school's appointed Medical Director to take measures to prevent the spread of illnesses. It has also been stated that as a school we need to maintain ideal indoor conditions to improve indoor air quality. It has been discovered that we need to improve upon the air circulation that our current heating/ventilation machinery offers us.

The doors that are due to be replaced inhibit this as well as allow for moisture to settle in those areas.

The District continues to use both nationally normed and locally created standards based benchmarks assessments. All assessments include both formative and summative benchmarking data points.

Our primary resources include:

1. AIMSWEB Plus for Math and ELA
2. DIAL
3. WISC Diagnostic
4. Teacher created standards based assessments
5. Resources used in primary source curriculum documents

On a weekly basis, our Pupil Services Team meets to discuss individual student progress. We use a range of progress monitoring tools (examples listed above) to monitor these. We have expanded student access to ELA and Math intervention services by increasing the number of service providers we house in buildings.

The District will reserve at least 20% of designated funds to bridge learning gaps in the following ways. With emphasis, we share that we understand that individual student needs as understood at this time will be further understood or evolve, we will continue to be responsive to target needs. We anticipate being able to use reflective practices to adopt additional strategies and methodologies to understand and address student needs.

- Add additional intervention specialists (Reading, Math, Special Education) teachers to provide academic support to students before, during, and after the school day; offer credit recovery; targeted after hours student tutoring; build school/family connections through summer and school year opportunities to engage through enrichment experiences (field trips, celebrations, parent involvement)
- Provide students with summer programming to build upon identified skill deficiencies; promote confidence in student academic development; and builds student understanding of maintaining a healthy lifestyle.

The District plans to use funding in the following investments in infrastructure that promotes safety, instructional programming to strengthen student skill sets, and provide needed resources that support optimal conditions for the safety of staff and students while learning through the pandemic. Examples include:

Physical Education Instructional Space: Creation of outdoor classroom/PE space including cleanable, poured rubber surfacing  
 HS Toilet Rooms: Toilet room renovations including individual toilet compartments, touchless fixtures, and scrubbable finishes  
 Door Replacement: Replacement of deteriorated exterior doors to reduce water infiltration and improve indoor air quality  
 Nurses Station: Renovation of existing nurse's suite to include private exam room, individual toilet room, and isolation area

The District is a high needs, low wealth district. Over 80% of our student population fall into a category listed in the prompt above. The majority of our students currently qualify for free and reduced lunch, a disproportionate number of our students are transient throughout the school year and we continue to provide supports to numerous students with disabilities as well as students who are homeless (or unaccompanied youth.)

Using a wide range of data points and accessing our weekly grade level meetings with advanced level pupil study teams, we review all students who have data reports (inclusive of behavioral; academic; social emotional; attendance; etc.) and target three to six weeks based intervention plans for each student regardless of their identification/subgrouping. This methodology has improved student attendance, developed our response plans to support students, and ultimately strengthen our student's academic success inclusive of graduation rates pre-pandemic. We will continue to use this model and further improve upon it to monitor our students.

We emphasize that data comes in many ways, we consider both qualitative as well as quantitative data in our analysis and it is rare that students have similar data profiles due to the scope of review that we conduct. This model is also used to monitor our RtI practices and student identification process for special education resources.

It is through the intentional efforts by ELA and Math interventionists and special educators, we have targeted progress monitoring tools and professional development to skill areas that students must demonstrate. Upon the discovery of deficits, interventionists will be addressing in 1:1 or small group programming.
