Purpose, Scope, Situation Overview, and Assumptions

Purpose

This plan has been developed in accordance with the amended New York State Labor Law section 27-c and New York State Education Law paragraphs k and l of subdivision 2 of section 2801-a (as amended by section 1 of part B of chapter 56 of the laws of 2016), as applicable. These laws were amended by the passing of legislation S8617B/A10832 signed by the Governor of New York State on September 7, 2020, requires public employers to adopt a plan for operations in the event of a declared public health emergency involving a communicable disease. The plan includes the identification of essential positions, facilitation of remote work for non-essential positions, provision of personal protective equipment, and protocols for supporting contact tracing.

Scope

This plan was developed exclusively for and is applicable to Hannibal Central School District. This plan is pertinent to a declared public health emergency in the State of New York which may impact our operations; and it is in the interest of the safety of our employees and contractors, and the continuity of our operations that we have promulgated this plan.

Situation Overview

On March 11, 2020 the World Health Organization declared a pandemic for the novel coronavirus which causes the COVID-19 severe acute respiratory syndrome. This plan has been developed in accordance with amended laws to support continued resilience for a continuation of the spread of this disease or for other infectious diseases which may emerge and cause a declaration of a public health emergency.

The health and safety of our employees and contractors is crucial to maintaining our mission essential operations. We encourage all employees and contractors to use [CDC Guidance for Keeping Workplaces, Schools, Homes, and Commercial Establishments Safe](#). The fundamentals of reducing the spread of infection include:

- Using hand sanitizer and washing hands with soap and water frequently, including:
 - After using the restroom
 - After returning from a public outing
 - After touching/disposing of garbage
 - After using public computers, touching public tables, and countertops, etc.
- Practice social distancing when possible
- If you are feeling ill or have a fever, notify your supervisor immediately and go home
- If you start to experience coughing or sneezing, step away from people and food, cough or sneeze into the crook of your arm or a tissue, the latter of which should be disposed of immediately
- Clean and disinfect workstations at the beginning, middle, and end of each shift
- Other guidance which may be published by the CDC, the State Department of Health, or County health officials.

Planning Assumptions

This plan was developed based on information, best practices, and guidance available as of the date of publication. The plan was developed to largely reflect the circumstances of the current Coronavirus pandemic but may also be applicable to other infectious disease outbreaks.

The following assumptions have been made in the development of this plan:

- The health and safety of our employees and contractors, and their families, is of utmost importance
- The circumstances of a public health emergency may directly impact our own operations.
- Impacts of a public health emergency will take time for us to respond to, with appropriate safety measures put into place and adjustments made to operations to maximize safety
- The public and our constituency expects us to maintain a level of mission essential operations
- Resource support from other jurisdictions may be limited based upon the level of impact the public health emergency has upon them
- Supply chains, particularly those for personal protective equipment (PPE) and cleaning supplies, may be heavily impacted, resulting in considerable delays in procurement
- The operations of other entities, including the private sector (vendors, contractors, etc.), non-profit organizations, and other governmental agencies and services may also be impacted due to the public health emergency, causing delays or other disruptions in their services
- Emergency measures and operational changes may need to be adjusted based upon the specific circumstances and impacts of the public health emergency, as well as guidance and direction from public health officials and the governor
- Per S8617B/A10832, 'essential employee' is defined as a public employee or contractor that is required to be physically present at a work site to perform their job
- Per S8617B/A10832, 'non-essential employee' is defined as a public employee or contractor that is not required to be physically present at a work site to perform their job

Concept of Operations

The Superintendent of Schools of Hannibal Central School District, their designee, or their successor holds the authority to execute and direct the implementation of this plan. Implementation, monitoring of operations, and adjustments to plan implementation may be supported by additional personnel, at the discretion of the Superintendent of Schools.

Upon the determination of implementing this plan, all employees and contractors of Hannibal Central School District shall be notified by district E-mail and School Messenger, with details provided as possible and necessary, with additional information and updates provided on a regular basis. Identify constituency groups will be notified of pertinent operational changes by way of identify means of public/constituent notification. Other interested parties, such as vendors, will be notified by phone and/or email as necessary. The Superintendent of Schools lead will maintain communications with the public and constituents as needed throughout the implementation of this plan.

The Superintendent of Schools of Hannibal Central School District, their designee, or their successor will maintain awareness of information, direction, and guidance from public health officials and the Governor's office, directing the implementation of changes as necessary.

Upon resolution of the public health emergency, the Superintendent of Schools of Hannibal Central School District, their designee, or their successor will direct the resumption of normal operations or operations with modifications as necessary.

Mission Essential Functions

When confronting events that disrupt normal operations, Hannibal Central School District is committed to ensuring that essential functions will be continued even under the most challenging circumstances.

Essential functions are those functions that enable an organization to:

1. Maintain the safety of employees, contractors, and our constituency
2. Provide vital services
3. Provide services required by law
4. Sustain quality operations
5. Uphold the core values of Hannibal Central School District

The Hannibal Central School District has identified as critical only those priority functions that are required or are necessary to provide vital services. During activation of this plan, all other activities may be suspended to enable the organization to concentrate on providing the critical functions and building the internal capabilities necessary to increase and eventually restore operations. Appropriate communications with employees, contractors, our constituents, and other stakeholders will be an ongoing priority.

Essential functions are prioritized according to:

- The time criticality of each essential function
- Interdependency of a one function to others
- The recovery sequence of essential functions and their vital processes

Priority 1 identifies the most essential of functions, with priority 4 identifying functions that are essential, but least among them.

The mission essential functions for Hannibal Central School District have been identified as:

Essential Function	Description	Priority
Communications	The Superintendent will lead all communications with all stakeholders to keep them informed on a weekly / bi-weekly basis.	1
Health & Safety	The district will review and consider the number of staff and students allowed to work in person safely. Teaching and Learning	To district will provide all students with a challenging educational program (in-person or remote)	1

These may be conducted in-person or remote. This will be consistent with Section III Athletics and NYSPHSAA.	4
Social Emotional Well-Being	The district will prioritize and provide supports for the social emotional well-being of students and staff in order to create the mental, social, and emotional space for academic learning to occur.	1
Community and Family Engagement	The district will continue to create opportunities for families and the larger community to engage in the educational process.	2

Essential Positions

Each essential function identified above requires certain positions on-site to effectively operate. The table below identifies the positions or titles that are essential to be staffed on-site for the continued operation of each essential function. Note that while some functions and associated personnel may be essential, some of these can be conducted remotely and do not need to be identified in this section.

Reducing Risk Through Remote Work and Staggered Shifts

Through assigning certain staff to work remotely and by staggering work shifts, we can decrease crowding and density at work sites and on public transportation

Remote Work Protocols

Non-essential employees and contractors able to accomplish their functions remotely will be enabled to do so at the greatest extent possible. Working remotely requires:

1. Identification of staff who will work remotely

Group A	Building Level Faculty and Staff: Teachers, TA, Aides/Monitors, OT/PT, Counselors, Psychologist, Nursing, Social Worker, SRO, Etc.
Group B	Clerical
Group C	Administration/Management

2. Approval and assignment of remote work—
 - a. The Superintendent will approve faculty and staff to work remotely.
 - b. Faculty and staff may be required to work a select number of days or hours in-district based upon need.
 - c. Hours per week for remote work will be determined based on need for in-person / remote work.
3. Equipping staff for remote work, which may include:
 - a. Internet capable laptop
 - b. Necessary peripherals

- c. Access to VPN and/or secure network drives
- d. Access to software and databases necessary to perform their duties
- e. A solution for telephone communications
 - i. Note that phone lines may need to be forwarded to off-site staff and/or all voicemail will be forwarded to E-mail.

Questions or concerns regarding technology, connectivity, etc., needed for remote work should be sent to the HCSD Director of Technology.

Staggered Shifts

Implementing staggered shifts may be possible for personnel performing duties which are necessary to be performed on-site but perhaps less sensitive to being accomplished only within core business hours. As possible, management will identify opportunities for staff to work outside core business hours as a strategy of limiting exposure. Regardless of changes in start and end times of shifts, Hannibal Central School District will ensure that employees are provided with their typical or contracted minimum work hours per week. Staggering shifts requires:

1. Identification of positions for which work hours will be staggered

Operations & Maintenance	O & M workers will be allowed to work 2 nd shift if / when it is necessary to reduce staffing numbers working 1 st shift.
Office Staff	The district will staff offices on an as needed basis to ensure the district and buildings are running properly.
Food Service Department	The Food Service Department will work as needed to ensure students receive proper healthy nutritional meals consistent with USDA guidelines, whether learning in-person or remote.
Transportation Department	The Transportation Department may work as needed to ensure the safety of students, its fleet, and may be needed to ensure food is delivered to students, if needed.

2. Approval and assignment of changed work hours

The Superintendent will approve the departments identified above to work staggered hours.

Personal Protective Equipment

The use of personal protective equipment (PPE) to reduce the spread of infectious disease is important to supporting the health and safety of our employees and contractors. PPE which may be needed can include:

- Masks
- Face shields
- Gloves
- Disposable gowns and aprons

Note that while cleaning supplies are not PPE, there is a related need for cleaning supplies used to sanitize surfaces, as well as hand soap and hand sanitizer. The Coronavirus pandemic demonstrated that supply chains were not able to keep up with increased demand for these products early in the pandemic. As such, we are including these supplies in this section as they are pertinent to protecting the health and safety of our employees and contractors.

Protocols for providing PPE include the following:

1. Identification of need for PPE based upon job duties and work location
 The district will review and follow OSHA guidance and CDC recommendations regarding providing PPE.
 At time of this plan was written (adopted):

Nurses	Face masks, eye protection, face shields, disposable gloves, disposable gowns
Staff with responsibilities related to health conditions and/or assist students with self-care	Face masks, eye protection, face shields, disposable gloves, disposable gowns
All other faculty and staff	Face masks
Contractor	Face masks
Students	Face masks

2. Procurement of PPE
 - a. As specified in the amended law, HCSD must be able to provide at least two pieces of each required type of PPE to each essential employee and contractor during any given work shift for at least six months.
 - b. HCSD will mitigate supply chain disruptions to meet this requirement.
3. Storage of, access to, and monitoring of PPE stock
 - a. PPE must be stored in a manner which will prevent degradation @ HS Basement or at Building designated areas
 - b. Employees and contractors will have immediate access to PPE in the event of an emergency
 - c. The supply of PPE will be monitored and distributed by our Director of Facilities to ensure integrity and to track usage rates.
 - d. Additional PPE will be ordered when supplies decrease and/or supply chains
4. The district will strive to maintain the following amounts (2-month supply) of PPE on hand at all times for its 1350 students and 275 faculty and staff members:

Hand Sanitizer	30 Gallons
Wipes	200,000

Staff Exposures, Cleaning, and Disinfection

Staff Exposures

Staff exposures are organized under several categories based upon the type of exposure and presence of symptoms. The New York State Department of Health has issued regulations, we have established the following protocols based on these regulations which are based on the CDC guidelines:

- A. If employees or contractors are exposed to a known case of communicable disease that is the subject of the public health emergency (defined as a 'close contact' with someone who is confirmed infected, which is a prolonged presence within six feet with that person):
 1. Potentially exposed employees or contractors who do not have symptoms should remain at home or in a comparable setting and practice social distancing for the lesser of 14 days or other current CDC/public health guidance for the communicable disease in question.
 - a. If possible, these employees will be permitted to work remotely during this period of time if they are not ill.
 - b. The Superintendent of Schools must be notified anytime there is a staff exposure who will, in turn report the incident to the appropriate Department of Health
 - c. The Superintendent of Schools will notify the Director of Facilities to clean and disinfect areas where any potential exposures may have taken place.

- B. If an employee or contractor exhibits or reports symptoms of the communicable disease that is the subject of the public health emergency:
 1. Employees and contractors who exhibit symptoms in the workplace should be immediately separated from other employees, customers, and visitors. They should immediately be sent home with a recommendation to contact their physician.
 2. Employees and contractors who exhibit symptoms outside of work should notify their supervisor and stay home, with a recommendation to contact their physician.
 3. Employees should not return to work until they have met the criteria to discontinue home isolation per CDC/public health guidance and have consulted with a healthcare provider.

4. The Hannibal Central Schools will not require sick employees to provide a negative test result for the disease in question or healthcare provider's note to validate their illness, qualify for sick leave, or return to work; they must follow the recommendation from the CDC/public health officials to Not return until after they are symptom free and/or have a release from their medical physical that the symptoms are not related to COVID-19
 5. CDC criteria for COVID-19 provides that persons exhibiting symptoms may return to work if:
 - a. They have a POSITIVE RESULT –**
 - i.* You must remain in isolation (at home and away from others) until your local health department has released you from isolation, which is typically:
 - 10 days after symptom onset; AND
 - Your symptoms are improving; AND
 - You are fever-free for at least 72 hours without use of fever reducing medicines.

While you are in isolation, all members of the household must quarantine at home until released by the local health department, typically 14 days.
 - b. They have a NEGATIVE RESULT –**
 - i.* If your symptoms are improving AND you are fever-free for at least 24 hours without the use of fever reducing medicines, you may return to school with:
 - A note from HCP indicating the test was negative OR
 - Provide a copy of the negative test result.
 6. The Superintendent of Schools must be notified in these circumstances and is responsible for ensuring these protocols are followed.
- C. If an employee or contractor has tested positive for the communicable disease that is the subject of the public health emergency:
1. Apply the steps identified in item B, above, as applicable.
 2. Areas occupied for prolonged periods of time by the subject employee or contractor will be closed off.
 - a. CDC guidance for COVID-19 indicates that a period of 24 hours is ideally given before cleaning, disinfecting, and reoccupation of those spaces will take place. If this time period is not possible, a period of as long as possible will be given. CDC/public health guidance for the disease in question will be followed.
 - b. Any common areas entered, surfaces touched, or equipment used shall be cleaned and disinfected immediately.
 - c. See the section on Cleaning and Disinfection for additional information on that subject.
 3. Identification of potential employee and contractor exposures will be conducted
 - a. If an employee or contractor is confirmed to have the disease in question, the Superintendent of Schools or their designee will work collaboratively with the Department of Health to inform all contacts of their possible exposure. Confidentiality shall be maintained as required by the Americans with Disabilities Act (ADA).
 - b. Apply the steps identified in item A, above, as applicable, for all potentially exposed personnel.
 4. The Superintendent of Schools must be notified in these circumstances and is responsible for ensuring these protocols are followed.

We recognize there may be nuances or complexities associated with potential exposures, close contacts, symptomatic persons, and those testing positive. We will follow CDC/public health recommendations and requirements and coordinate with our local public health office for additional guidance and support as needed.

Cleaning and Disinfecting

CDC/public health guidelines will be followed for cleaning and disinfection of surfaces/areas. Present guidance for routine cleaning during a public health emergency includes:

1. As possible, employees and contractors will clean their own workspaces in the beginning, middle, and end of their shifts, at a minimum.
 - a. High traffic/high touch areas and areas which are accessible to the public/constituents will be disinfected at least hourly, to the best of our ability.
 - b. Building custodial staff will be responsible for cleaning common areas, and the frequency of such:
 - i. High Touch Surfaces – Multiple times throughout the day.
 - ii. Classrooms – Nightly and as needed.
 - iii. Bathrooms – Hourly.
 - iv. Common Areas – Daily.
 - v. Busses – In between routes.
2. Staff tasked with cleaning and disinfecting areas will be issued and required to wear PPE appropriate to the task.
3. Soiled surfaces are cleaned and disinfected with Clorox 360 machines or similar electrostatic disinfectant machines.
4. Surfaces will be disinfected with products that meet EPA criteria for use against the virus in question and which are appropriate for that surface.
5. Staff will follow instructions of cleaning products to ensure safe and effective use of the products.

Employee and Contractor Leave

Public health emergencies are extenuating and unanticipated circumstances in which the Hannibal Central Schools is committed to reducing the burden on our employees and contractors. The *Families First Coronavirus Response Act* provided requirements related to the COVID-19 pandemic, which form the policies outlined below. This policy may be altered based upon changes in law or regulation, as applicable.

It is our practice that employees of the Hannibal Central Schools will not be charged with leave time for testing while The Families First Coronavirus Response Act is enacted. Employees will be provided with up to 10 days of paid sick leave at the employee's regular rate of pay for a period which the employee is unable to work due to waiting for test results, quarantine (in accordance with federal, state, or local orders or advice of a healthcare provider), and/or experiencing symptoms and seeking medical diagnosis.

Additionally, the Hannibal Central Schools will provide up to an additional 10 weeks of paid expanded family and medical leave at two-thirds of the employee's regular rate of pay where an employee, who has been employed for at least 30 calendar days by the Hannibal Central Schools, is unable to work due to a bona fide need for leave to care for a child whose school or child care provider is closed or unavailable for reasons related to the public health emergency. This provision may be modified if an employee is able to effectively work remotely and the need exists for them to do so.

Additional provisions and/or changes may take place based upon need and the guidance and requirements put in place by federal and state employment laws, FMLA, executive orders, Department of Health guidance, etc.

Contractors, either independent or affiliated with a contracted firm, are not classified as employees of the Hannibal Central Schools, and as such are not provided with paid leave time by the Hannibal Central Schools, unless required by law.

Documentation of Work Hours and Locations

In a public health emergency, it may be necessary to document work hours and locations of each employee and contractor to support contact tracing efforts. Identification of locations shall include on-site work, off-site visits. This information may be used by the Hannibal Central Schools to support contact tracing within the organization and may be shared with local public health officials.

The Superintendent will approve and communicate faculty and staff to work in-district and/or remotely. Faculty and staff may be required to work a select number of days or hours in-district based upon need. Hours per week for remote work will be determined based on need for in-person / remote work.

Housing for Essential Employees

There are circumstances within a public health emergency when it may be prudent to have essential employees lodged in such a manner which will help prevent the spread of the subject communicable disease to protect these employees from potential exposures, thus helping to ensure their health and safety and the continuity of the Hannibal Central School's essential operations.

If such a need arises, hotel rooms are expected to be the most viable option. If hotel rooms are for some reason deemed not practical or ideal, or if there are no hotel rooms available, the Hannibal Central Schools will coordinate with the Oswego County Emergency Management Office to help identify and arrange for these housing needs.

The Superintendent of Schools will coordinate this effort.
